**I. CALL TO ORDER** – Called to order the Local CORP Board meeting by **Michael Smarik** at **10:00 a.m., Thursday November 6, 2014.**

**III. DISABILITY RETIREMENTS –**

- a. **Daniel Herrera** – Ordinary Disability - Jeffrey Potter has contacted 27 doctor’s office and has not been able to find a doctor to perform the IME. He has received approval from Mr. Herrera to search in Phoenix if a doctor in Tucson cannot be found. Mr. Potter stopped the doctor search to wait for directions from the Board. The Board requests him to complete the search and notify Procurement when an appropriate doctor is found.
- b. **Esteban Tanori** – Ordinary Disability application. Jeffrey Potter reported that he has received all of the medical documents and forms from Mr. Tanori. The Board received a packet of documents from Mr. Tanori for their review.
- c. **Corey Kuykendall** – Total & Permanent/Accidental disability application. The IME doctor reported that there seems to be some missing medical documents. Mary Turner will research the medical documents and if there are missing documents she will request them from Mr. Kuykendall. Mary Turner also reported there is an issue with Procurement on

approving the estimated bill.

- d. **Requesting Independent Medical Exam (IME)** – Discussion and appropriate action regarding on how the Board will find and approve an IME doctor.

Mary Turner reports that she had a conversation with the Procurement staff. When Ms. Turner submitted the IME bill for \$6500, the Procurement staff reported that the Board would be required to follow the Procurement procedures due to the cost. This is the first time an IME has not been approved.

Discussions with Michael Smarik and Procurement continued and the results are that the Board is required to follow the Procurement rules. When an IME is required, the Board staff will research what type of doctor is required, interview the doctor's office to determine if the doctor is willing to do an IME and accept payment from the DOC through procurement. The Board's staff will contact Procurement, inform them of their search results; including the number of doctors called, any special requirements a doctor would need, and the cost.

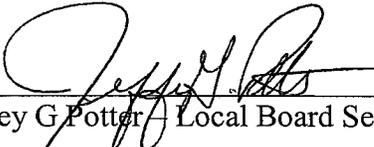
