Board Member Frigo further stated that thus, the doctor addressed the pre-existing conditions, and the doctor emphasized that those pre-existing conditions were made worse by COVID. Assistant Attorney General Cummings suggested that the Local
	Board indicate on the record whether the disability resulted from a pre-existing condition; Board Member Frigo stated that the pre-existing conditions did not have anything to do with what eventually caused his deterioration, which was
	the COVID and all the elements that came with the COVID afterwards.

Ms. Collins further explained the dangers she faces on the job due to her hearing issues, how reasonable accommodations could not be made for her hearing issues, and how she is unable to participate in mandatory job training due to her hearing issues. Ms. Collins finished by requesting that her application for a disability pension be granted.
