**1. Scott Mills:** Review of Dr. Oppenheim's IME Clarification /Addendum Letter. IME Review for Accidental Disability Pension.

Board Member Frigo stated that she had a question and wanted to know from their attorney whether the Board needed to go into Executive Session. Board Member Frigo explained that her question was in regards to how, after reading the documentation, she saw that Dr. Oppenheim sent the Board the requested documentation that the two suicide attempts occurred during Mr. Mills employment with ADC. Board Member Frigo then noted how there were actually three suicide attempts.

Board Member Frigo also noted how page six of the IME says that Mr. Mills resigned for three months in 2004 and then again in 2012, returning in approximately 2014. Board Member Frigo then stated that her question is that, for this disability pension request, do the suicide attempts have to have been since 2014, or does the Board go back to the beginning of Mr. Mills' employment in 1998?

AAG Cummings stated that because the question goes into statutory interpretation and what the laws require, he suggests that the Board go into Executive Session.
