2. Miguel Garcia IME Review for Accidental Disability Pension.

Chairwoman Stickley stated the following clarification at the start of this item:

When an IME was being scheduled for Mr. Garcia, it was found that Mr. Garcia had previously seen a different doctor years ago at this same clinic for a workers' comp issue; that doctor left the clinic in 2022.

Mr. Garcia also saw a Nurse Practitioner at that clinic on the workers' comp issue in 2023.

For the IME at issue here, the doctor Mr. Garcia saw was Dr. Ross, who has never seen Mr. Garcia before, and Dr. Ross is not a regular employee or contractor of DOC; Dr. Ross is the only specialist able to do an IME for this sort of medical issue within 150 miles.

Karen Ray reached out to PSPRS to see if they saw any issue with this situation, and PSPRS asked that the CORP Board be sure to have in the minutes why this clinic/doctor was chosen, so PSPRS understands the entire situation regarding the clinic and doctor.
