



**Arizona Department of Corrections Rehabilitation and Reentry
Prison Rape Elimination Act (PREA)
Annual Report**

PREA Background

PREA was established in 2003 to address sexual abuse and sexual harassment of persons in the custody of U.S. correctional agencies. Major provisions of PREA include the development of standards for detection, prevention, reduction and punishment of sexual abuse and sexual harassment in confinement settings. The Act applies to all public and private institutions that house adult or juvenile offenders. On August 20, 2012, the PREA standards final rule became effective.

The Arizona Department of Corrections Rehabilitation and Reentry has a zero tolerance policy on issues pertaining to sexual abuse and sexual harassment involving inmates and is working continuously to develop and implement policies to prevent, detect, and respond to sexual misconduct allegations.

Definitions

Substantiated allegation means an allegation was investigated and determined to have occurred.

Unsubstantiated allegation means an allegation was investigated and the investigation produced insufficient evidence to make a final determination as to whether or not the event occurred.

Unfounded allegation means an allegation was investigated and determined not to have occurred.

2021 Analysis/Corrective Action

The Arizona Department of Corrections Rehabilitation and Reentry is reporting information on inmates held in all state-operated facilities from January 1, 2021 through December 31, 2021. During this time period there were four ADCRR facilities that were PREA audited. Those facilities were ASPC Lewis, ASPC Tucson, ASPC Yuma and the Pima County Release Center (community confinement facility) All required PREA audits were completed on schedule as the department partially returned to normal operations following the COVID 19 pandemic. All facilities audited during this time period met the required 43 standards and hundreds of provisions/elements within each standard.

ADCRR is happy to report that all facilities operated by ADCRR and all privately operated facilities have certified full compliance with the National standards to prevent, detect, and respond to prison rape.

Analysis of the aggregated data collected during this time period continues to further illustrate the department's commitment to sexual safety in our facilities and a culture of zero tolerance that has become institutionalized. In ADCRR-managed facilities there were a total of 7 substantiated cases of sexual abuse/sexual harassment. This number remains the same from what was reported in 2020.

The ADCRR continues to strive for a prison system that remains safe for inmates, employees, contract staff and volunteers alike, through continued training, education and official PREA audits. ADCRR continues to assess and implement changes to infrastructure, barriers for privacy, enhanced monitoring technology, access to services and reporting mechanisms and staffing patterns to illustrate our commitment to enhancing sexual safety.
