Due to space limitations, food visitation will be on a "first in, first out" basis. Each visitor that arrives before 1200 hours will be authorized a minimum (4) hour visit. If the visitation area reaches seating capacity, we will first ask for volunteers to leave. If the seating capacity is still at the limit and a sufficient amount of volunteers have not been found, we will then ask the visitors that were "first in" to exit, so that other eligible inmates are allowed the opportunity to participate in the Food Visit.
